

CONTROLLING BLOOD PRESSURE (CBP)

PROVIDER TIP SHEET



What is Being Measured?

The Controlling Blood Pressure (CBP) measure assesses the percentage of members between 18 and 85 years of age, who had a diagnosis of hypertension and whose blood pressure was adequately controlled (<140/90 mm Hg) during the measurement year.



NOTE: When multiple BP readings are included in the chart on the same date, the lowest systolic and diastolic BP results will be used.



Why is This Measure Important?

Hypertension puts members at a higher risk for stroke and heart disease. Helping members keep their blood pressure controlled reduces the risk of developing other co-morbidities. Medication, healthy diet, and physical activity are just a few of the ways to help members keep their blood pressure at a controlled level.



Eligible Population

All members aged 18-85 years old are included in this measure.

**Best
Practices**

- Educate members on the risks associated with hypertension and ways to keep their BP under control.
- Check for any barriers that may be keeping members from filling their prescriptions.
- Ensure that clinical staff are repeating BP check if it is abnormally low or high.
- If BP is above 140/90, retake the BP after the member has had some time to rest.
- When including member-reported BP, make sure to include documentation in the member’s chart including exact reading and dates of the reported blood pressure.
- Include a BP CPT II-code in addition to ICD-10 code for hypertension.
