

Clinical Policy: Gilteritinib (Xospata)

Description

Gilteritinib (Xospata®) is a tyrosine kinase inhibitor.

FDA Approved Indication(s)

Xospata is indicated for the treatment of adult patients who have relapsed or refractory acute myeloid leukemia (AML) with a FMS-like tyrosine kinase 3 (FLT3) mutation as detected by an FDA-approved test.

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that Xospata is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

- A. Acute Myeloid Leukemia (must meet all):
 - 1. Diagnosis of relapsed or refractory AML;
 - 2. Prescribed by or in consultation with an oncologist or hematologist;
 - 3. Age \geq 18 years;
 - 4. For Xospata request, medical justification supports inability to use gilteritinib, if available, (e.g., contraindications to excipients);
 - 5. Documentation of an FLT3 mutation;
 - 6. Request meets one of the following (a or b):*
 - a. Dose does not exceed 120 mg (3 tablets) per day.
 - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

*Prescribed regimen must be FDA-approved or recommended by NCCN

Approval duration:

Medicaid/HIM – 6 months

Commercial – Length of Benefit

B. Myeloid/Lymphoid Neoplasm with Eosinophilia (off-label) (must meet all):

- 1. Diagnosis of a myeloid/lymphoid neoplasm with eosinophilia (MLNE);
- 2. Prescribed by or in consultation with an oncologist or hematologist;
- 3. Age \geq 18 years;
- 4. For Xospata request, medical justification supports inability to use gilteritinib, if available, (e.g., contraindications to excipients);



- 5. Documentation of an FLT3 mutation;
- 6. Dose is within FDA maximum limit for any FDA-approved indication or is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (prescriber must submit supporting evidence).*

*Prescribed regimen must be FDA-approved or recommended by NCCN

Approval duration:

Medicaid/HIM – 6 months

Commercial – Length of Benefit

C. Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

II. Continued Therapy

A. All Indications in Section I (must meet all):

- 1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Xospata for a covered indication and has received this medication for at least 30 days;
- 2. Member is responding positively to therapy;
- 3. For Xospata request, medical justification supports inability to use gilteritinib, if available, (e.g., contraindications to excipients);
- 4. If request is for a dose increase, request meets one of the following (a or b):*
 - a. New dose does not exceed 120 mg (3 tablets) per day.
 - b. New dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).

*Prescribed regimen must be FDA-approved or recommended by NCCN

Approval duration:

Medicaid/HIM – 12 months

Commercial – Length of Benefit

B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 6 months (whichever is less); or

2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid, or evidence of coverage documents.
