

## **Clinical Policy: Suvorexant (Belsomra)**

### Description

Suvorexant (Belsomra<sup>®</sup>) is an orexin receptor antagonist.

### FDA Approved Indication(s)

Belsomra is indicated for the treatment of insomnia characterized by difficulties with sleep onset and/or sleep maintenance.

### **Policy/Criteria**

*Provider must submit documentation (including such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.* 

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Belsomra is **medically necessary** when the following criteria are met:

### I. Initial Approval Criteria

- A. Insomnia (must meet all):
  - 1. Diagnosis of insomnia;
  - 2. Age  $\geq$  18 years;
  - 3. Failure of two preferred or formulary agents indicated for insomnia (*see Appendix B for examples*) at maximally indicated doses, unless clinically significant adverse effects are experienced or all are contraindicated;
  - 4. Dose does not exceed 20 mg (1 tablet) per day.

## **Approval duration: 6 months**

### **B.** Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): HIM.PHAR.21 for health insurance marketplace and CP.PMN.53 for Medicaid.

### **II.** Continued Therapy

- A. Insomnia (must meet all):
  - 1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
  - 2. Member is responding positively to therapy;
  - 3. If request is for a dose increase, new dose does not exceed 20 mg (1 tablet) per day. Approval duration: 12 months



### **B.** Other diagnoses/indications (must meet 1 or 2):

- 1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.
  - Approval duration: Duration of request or 12 months (whichever is less); or
- Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): HIM.PHAR.21 for health insurance marketplace and CP.PMN.53 for Medicaid.

### **III. Diagnoses/Indications for which coverage is NOT authorized:**

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – HIM.PHAR.21 for health insurance marketplace and CP.PMN.53 for Medicaid, or evidence of coverage documents.
