

Clinical Policy: Isavuconazonium (Cresemba)

Description

Isavuconazonium (Cresemba[®]) is an azole antifungal.

FDA Approved Indication(s)

Cresemba is indicated for the treatment of:

- Invasive aspergillosis in patients 18 years of age and older
- Invasive mucormycosis in patients 18 years of age and older

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that Cresemba is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

A. Aspergillosis (must meet all):

1. Diagnosis of invasive aspergillosis;
2. Age \geq 18 years;
3. Prescribed by or in consultation with an infectious disease specialist;
4. Failure of voriconazole at up to maximally indicated doses, unless contraindicated or clinically significant adverse effects are experienced;
5. Dose does not exceed the following:
 - a. Loading dose: 372 mg (2 capsules or 2 vials) every 8 hours for 48 hours (total 6 doses: 12 capsules or 6 vials);
 - b. Maintenance dose: 372 mg (2 capsules or 2 vials) per day.

Approval duration: 3 months

B. Mucormycosis (must meet all):

1. Diagnosis of invasive mucormycosis;
2. Age \geq 18 years;
3. Prescribed by or in consultation with an infectious disease specialist;
4. Dose does not exceed the following:
 - a. Loading dose: 372 mg (2 capsules or 2 vials) every 8 hours for 48 hours (total 6 doses: 12 capsules or 6 vials);
 - b. Maintenance dose: 372 mg (2 capsules or 2 vials) per day.

Approval duration: 3 months

C. Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

II. Continued Therapy

A. All Indications in Section I (must meet all):

1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
2. Member is responding positively to therapy;
3. If request is for a dose increase, new dose does not exceed 372 mg (2 capsules or 2 vials) per day.

Approval duration: 6 months

B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.
Approval duration: Duration of request or 12 months (whichever is less); or
2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

III. Diagnoses/Indications for which coverage is NOT authorized:

- A.** Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid, or evidence of coverage documents.

Appendix B: Therapeutic Alternatives

This table provides a listing of preferred alternative therapy recommended in the approval criteria. The drugs listed here may not be a formulary agent for all relevant lines of business and may require prior authorization.

Drug Name	Dosing Regimen	Dose Limit/ Maximum Dose
voriconazole (Vfend [®])	Aspergillosis <u>IV</u> : 6 mg/kg/dose IV every 12 hours on day 1, followed by 4 mg/kg/dose IV every 12 hours. If patient is unable to tolerate maintenance therapy, reduce dose to 3 mg/kg/dose IV every 12 hours.	Weight ≥ 40 kg: 12 mg/kg/day IV; 800 mg/day PO

Drug Name	Dosing Regimen	Dose Limit/ Maximum Dose
	<p><u>PO:</u> <i>Adults weighing 40 kg or more:</i> 200 mg PO every 12 hours beginning after at least 7 days of IV voriconazole therapy. Increase to 300 mg PO every 12 hours for inadequate response; if not tolerated, taper by 50 mg increments to minimum 200 mg PO every 12 hours. <i>Adults weighing less than 40 kg:</i> 100 mg PO every 12 hours beginning after at least 7 days of IV voriconazole therapy. Increase to 150 mg PO every 12 hours for inadequate response; if not tolerated, reduce dose to minimum 100 mg PO every 12 hours.</p> <p>Clinical practice guidelines suggest voriconazole as primary therapy. Treat for at least 6 to 12 weeks with duration dependent on extent and length of immunosuppression, infection site, and disease improvement.</p>	<p>Weight < 40 kg: 12 mg/kg/day IV; 400 mg/day PO</p>

Therapeutic alternatives are listed as Brand name[®] (generic) when the drug is available by brand name only and generic (Brand name[®]) when the drug is available by both brand and generic.

Appendix C: Contraindications/Boxed Warnings

- Contraindication(s):
 - Hypersensitivity to Cresemba
 - Coadministration of strong CYP3A4 inhibitors, such as ketoconazole or high-dose ritonavir (400 mg every 12 hours), because strong CYP3A4 inhibitors can significantly increase the plasma concentration of isavuconazole
 - Coadministration of strong CYP3A4 inducers, such as rifampin, carbamazepine, St. John’s wort, or long acting barbiturates because strong CYP3A4 inducers can significantly decrease the plasma concentration of isavuconazole
 - Familial short QT syndrome. Cresemba shortened the QTc interval in a concentration-related manner

VI. Product Availability

- Capsule: 186 mg of isavuconazonium sulfate (equivalent to 100 mg of isavuconazole)
- Single-dose vial for injection: 372 mg of isavuconazonium sulfate (equivalent to 200 mg of isavuconazole)
