

**Clinical Policy: Triclabendazole (Egaten)**

## **Description**

Triclabendazole (Egaten<sup>™</sup>) is an anthelmintic agent.

## FDA Approved Indication(s)

Egaten is indicated for the treatment of fascioliasis in patients 6 years of age and older.

#### Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Egaten is **medically necessary** when the following criteria are met:

### I. Initial Approval Criteria

#### A. Fascioliasis (must meet all):

- 1. Diagnosis of fascioliasis;
- 2. Prescribed by or in consultation with an infectious disease specialist or gastroenterologist;
- 3. Age  $\geq$  6 years;
- 4. Dose does not exceed 10 mg/kg per dose for 2 doses.

**Approval duration: 4 weeks (no more than 2 total doses)** 

#### **B.** Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace, and CP.PMN.53 for Medicaid.

## **II. Continued Therapy**

#### A. Fascioliasis

1. Re-authorization is not permitted. Members must meet the initial approval criteria for new cases of fascioliasis unrelated to the original medication request.

Approval duration: Not applicable

#### **B.** Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

### Approval duration: Duration of request or 6 months (whichever is less); or

2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace, and CP.PMN.53 for Medicaid.

## III. Diagnoses/Indications for which coverage is NOT authorized:

**A.** Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace, and CP.PMN.53 for Medicaid or evidence of coverage documents.

Indication	Dosing Regimen	Maximum Dose
Fascioliasis	Two doses of 10 mg/kg PO 12 hours apart*	Two doses of 10 mg/kg

<sup>\*</sup>The 250 mg tablets are functionally scored and divisible into two equal halves of 125 mg. If the dosage cannot be adjusted exactly, round the dose upwards.
