

Clinical Policy: Seladelpar (Livdelzi)

Description

Seladelpar (Livdelzi®) is a peroxisome proliferator-activated receptor (PPAR)-delta agonist.

FDA Approved Indication(s)

Livdelzi is indicated for the treatment of primary biliary cholangitis (PBC) in combination with ursodeoxycholic acid (UDCA) in adults who have an inadequate response to UDCA, or as monotherapy in patients unable to tolerate UDCA.*

Limitation(s) of use: Use of Livdelzi is not recommended in patients who have or develop decompensated cirrhosis (e.g., ascites, variceal bleeding, hepatic encephalopathy).

*This indication is approved under accelerated approval based on reduction of alkaline phosphatase (ALP). Improvement in survival or prevention of liver decompensation events have not been demonstrated. Continued approval for this indication may be contingent upon verification and description of clinical benefit in confirmatory trial(s).

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation® that Livdelzi is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

- A. Primary Biliary Cholangitis (must meet all):
 - 1. Diagnosis of PBC;
 - 2. Prescribed by or in consultation with a hepatologist or gastroenterologist;
 - 3. Age \geq 18 years;
 - 4. Failure (as evidenced by sustained elevation in ALP ≥ 1.67 times the upper limit of normal) of ≥ 12 month trial of UDCA (ursodiol) at a dose of ≥ 13 mg/kg/day, unless contraindicated or clinically significant adverse effects are experienced;
 - 5. Prescribed in combination with UDCA, unless contraindicated or clinically significant adverse effects are experienced;
 - 6. Dose does not exceed 10 mg (1 capsule) per day.

Approval duration: 6 months

B. Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business:
 CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or
- 2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

II. Continued Therapy

A. Primary Biliary Cholangitis (must meet all):

- 1. Member meets one of the following (a or b):
 - a. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
 - b. Member is currently receiving medication and is enrolled in a state and product with continuity of care regulations (refer to state specific addendums for CC.PHARM.03A and CC.PHARM.03B);
- 2. Member is responding positively to therapy as evidenced by one of the following (a or b):
 - a. Initial reauthorization: reduction in ALP level from pretreatment level;
 - b. Subsequent reauthorization: continued reduction or maintenance of initial reduction in ALP level;
- 3. If request is for a dose increase, new dose does not exceed 10 mg (1 capsule) per day. **Approval duration: 12 months**

B. Other diagnoses/indications (must meet 1 or 2):

- 1. If this drug has recently (within the last 6 months) undergone a label change (e.g., newly approved indication, age expansion, new dosing regimen) that is not yet reflected in this policy, refer to one of the following policies (a or b):
 - a. For drugs on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the no coverage criteria policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.33 for health insurance marketplace, and CP.PMN.255 for Medicaid; or
 - b. For drugs NOT on the formulary (commercial, health insurance marketplace) or PDL (Medicaid), the non-formulary policy for the relevant line of business: CP.CPA.190 for commercial, HIM.PA.103 for health insurance marketplace, and CP.PMN.16 for Medicaid; or

2. If the requested use (e.g., diagnosis, age, dosing regimen) is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized) AND criterion 1 above does not apply, refer to the off-label use policy for the relevant line of business: CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid.

III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial, HIM.PA.154 for health insurance marketplace, and CP.PMN.53 for Medicaid or evidence of coverage documents.

ursodiol (Urso Forte®)	13-15 mg/kg/day PO in 2-4 divided doses	15 mg/kg/day

Appendix D: General Information

- According to the AASLD Primary Biliary Cirrhosis 2018 practice guidelines, UDCA dosed at 13-15 mg/kg/day orally is recommended for all patients with PBC who have abnormal liver enzyme values regardless of histological stage. Improvement in liver tests will be seen within a matter of a few weeks and 90% of the improvement usually occurs within 6-9 months. The eligibility criteria in the Livdelzi efficacy trial required enrolled patients to have a minimum 12 month history of taking UDCA.
- In the Livdelzi clinical trial, biochemical response was defined as achieving ALP less than 1.67-times ULN, an ALP decrease of greater than or equal to 15% from baseline, and total bilirubin (TB) less than or equal to ULN. The ULN for ALP was defined as 116 U/L. The ULN for TB was defined as 1.1 mg/dL.
 - At month 12, improvement in ALP was the main contributor to the biochemical response rate results.

- A diagnosis of PBC can be established when two of the following three criteria are met:
 - o ALP is elevated above the upper limit of normal as defined by normal laboratory references values;
 - o Positive anti-mitochondrial antibodies (AMA) or other PBC-specific auto-antibodies, including sp100 or gp210, if AMA is negative;
 - o Histologic evidence of PBC from a liver biopsy.
